Keeping you informed...

Welcome to our first community update newsletter, a regular communication for people living close to our Whatley and Westdown quarries. Our aim is to keep you informed about what is happening at our East Mendip operations as well as our plans for the future.

We are committed to being a good neighbour and working constructively with local communities so we can continue to provide vital construction materials while minimising our impact on the areas in which we operate. As we set out in our recent proposals to update permissions for Westdown, our vision in the East Mendips is to implement a combined approach across the two quarries, which will help minimise the impact of our operations, benefiting neighbouring communities.

Our overarching principle is that the operations of both quarries, including mineral volumes and vehicle movements, will not exceed the current levels for Whatley. We plan to do this by using Westdown's location, close to key road routes, to supply local demand, freeing up the rail link at Whatley to allow more material

for national markets to go by rail. These combined steps will cut our carbon footprint and reroute vehicles away from local villages.

What's more, our proposals for Westdown quarry will also deliver a transformative legacy project through the restoration of the adjacent Asham Wood (see Westdown update on page 3).

We believe that this dual approach offers real benefits to the East Mendips. We're committed to keeping local people updated about our proposals and, when Covid regulations permit, we'll be more active in engaging with local people and stakeholders.

Whiteboard donation supports learning

The pupils of Mells Church of England First School have a new look classroom thanks to the installation of a £2,900 interactive whiteboard funded by Hanson.

The board is an essential tool for teaching and learning as it allows images from a computer screen to be projected for the whole class to view at the same time.

"With pupils returning to the classroom fulltime following the pandemic, the whiteboard is proving invaluable in helping to develop the children's problem-solving skills," said head teacher, Claire Chantler. Hanson's strategic development manager lan Strachan added: "Teaching methods have changed since I was at school, but it's great to know that we are supporting the pupils to get the most from their learning."

Ash dieback has caused the widespread loss of ash trees and is now affecting woodlands, paths and gardens closer to home. Already over 2,500 diseased trees have been identified in the Mendip Hills.

Woodland management


Experts believe that up to 95 per cent of UK ash trees could fall victim to ash dieback, which causes leaf loss and crown dieback and can lead to death or windthrow of affected trees.

This serious disease is unfortunately affecting ash trees on our Westdown and Whatley quarry sites as well as land we own adjacent to the river at Vallis Vale.

In light of this, at Asham Wood, where the proposals to reopen the adjacent Westdown quarry will include restoring some of the adjacent Asham void to provide a buffer of new tree planting around the core ancient wood, we will be working with the Forestry Commission and Natural England to review our woodland management plans.

In addition to necessary tree felling along footpaths, we are also considering our coppicing regime and if planting replacement trees is appropriate. At Vallis Vale, we are applying for a tree felling licence to remove trees posing a safety risk and, at Whatley, we are a keeping close watch on impacted trees.

Principal landscape manager, Andy Duncan, said: "It's not just about managing diseased and hazardous trees: with ash dieback we also have to think about protecting the overall integrity of our woodlands to ensure we maintain their ecological functionality."





Widening group membership

Update on application at Westdown quarry

Thank you to everyone who got in contact and provided constructive feedback in our online pre-application consultation on the future of Westdown quarry.

The quarry has permission for mineral extraction until 2042, but our application to update the existing planning permissions would bring them in line with current standards ahead of restarting operations. We have now submitted our proposals to Somerset County Council and,

subject to approvals, we would aim to restart work in 2022.

Trystan Mabbit, consenting and development manager, said: "Our application at Westdown quarry includes the phased restoration of the adjacent Asham Wood and has been shaped by the need to protect wildlife and reduce the impact of our activities on the environment. The scheme will provide significant environmental and biodiversity benefits as well as enhanced public rights of way."

Ongoing site assessments

As part of our commitment to operate within legislative guidelines on noise and vibration, you may notice some independent specialists in the area carrying out testing.

Nine sites around Whatley are being monitored using highly calibrated technical equipment and once the studies are complete, we will share the findings along with any operational amendments that are identified.

Whatley Wombles

We have resumed litter picking along the grass verges on roads close to our Whatley quarry and have also started a regular pick-up of rubbish, including fly tipped material, around Westdown.

Clean sweep

We have deployed a road sweeper to visit Chantry, Mells and Whatley once a week to ensure local roads are kept as clean as possible.



Future leaders

Over the last decade Hanson has recruited more than 60 apprentices onto its three-year Leadership Education and Development (LEAD) programme for post-sixth form school-leavers, plus over 35 graduates have joined our trainee manager programme.

Pictured left is the five-strong cohort of LEAD and graduate programme participants currently based at Whatley. Graduate Joanna Hudd said: "Working in the minerals sector offers great training and career progression. I am really excited for the future."



River opened up for fishing

Wellbeing is a key priority for Hanson and we are extending our association with Frome and District Angling Association (FADAA) to open up more of the river frontage we own to angling.

With fishing participation rates increasing over the last year, we are pleased that our plans include providing a stretch of the River Mells specifically for free fishing for local under 16 year-olds between the duck pond and the weir in Great Elm. Signage is in development and we are grateful to FADAA for their support in rolling out this initiative.

Providing support for local initiatives

Local charities and community groups across the East Mendips have received extensive support during the last year, thanks to our community assistance initiatives.

We're particularly proud that early in the first lockdown we were able to donate vital PPE for use by Somerset Adult Social Care and Support and well as making financial contributions to other worthy local causes, including supporting disabled riders at Divoky Riding School.

Hanson also has a programme of employee volunteering days to work on community projects and recently local activity has included litter picking and maintenance in St Andrew's graveyard in Mells.
