A busy six months at our quarries...

Welcome to our second community update newsletter. It's been a busy six months at our quarries in the East Mendips.

At Whatley quarry we are rolling out a £10 million upgrade to plant which will include the delivery of new trucks this autumn. We have also been trialling a number of site adaptations including stopping quarry extraction, along with the cessation of activities at the primary crusher, earlier at night. Plus, the load and haul and primary plant have not been used over the weekend since the start of this year and this will continue.

We have also been adapting our approach to blasting (see page 2), with our highly regarded industry specialists trialling new blast designs to mitigate perceived vibration. While we operate well within the applicable blasting limits, we are actively responding to feedback and are committed to making improvements where we can.

Following attendance at recent parish council meetings in the communities around Westdown, we have provided further detail



on some key aspects of our proposals to update the existing planning consents in response to the queries received from local people. This information can be downloaded from the documents and materials page of our website. We've also been listening to feedback and have clarified our position on a number of issues and indicated where we would be seeking to work closely with local stakeholders in the future to further develop and implement aspects of our proposals.

The Mineral Planning Authority – in this case Somerset County Council (SCC) – has now completed its own public consultation on our proposals and we are expecting a determination

of our planning application later this autumn. Reopening Westdown will not only secure long-term supplies of vital construction materials but would also deliver a transformational legacy project through the progressive restoration of the guarry and the adjacent Asham Wood void.

Quarry fan visits Whatley

We were thrilled to welcome four-year-old Benji from Coleford to Whatley and show him his favourite quarry vehicles up close.

Mum Catherine Farmer had been in touch to tell us how much he enjoyed visiting the viewing platform (located at grid reference 51°13'53.2"N 2°24'05.1"W) ahead of his nursery sessions nearby and that he was fascinated by all aspects of the quarry's operations – but especially the diggers.

Catherine said: "He had an absolutely amazing time. He has loved telling everyone about it and is now enjoying spotting the numbers on the front of the vehicles when we view in the morning, which we hadn't noticed before the visit."

Justin Collis, Hanson area operations manager, added: "With Covid restrictions lifting it's been good to welcome visitors back to Whatley to show what happens on site and explain how the aggregates extracted are used."

Blasting update and launch of blast notification service

We've been reviewing our approach to blasting to minimise disruption for our neighbours.

Recent adaptations in blast design include trialling double decking and triple decking to reduce vibration. These methods involve charging explosives at two, or three, positions in one hole while keeping the same volume of explosive as a traditional one-hole simultaneous blast. We are also trialling blasting within more stringent self-imposed parameters on the south face of the quarry.

Justin Collis, area operations manager, said: "Quarry blasting in the UK is highly regulated. While geology is the most significant factor in determining the way in which a vibration wave from a quarry blast is transmitted, the energy of the wave – shaped by the kind of explosive, the




explosive charge, as well as blasting geometry and pattern – will also influence vibration levels. By adapting blast design on the south face, we are working to reduce vibration levels and thereby the way in which a blast is experienced."

Westdown security update

Following feedback from local people, we've taken extra steps to prevent disturbances caused by anti-social behaviour at Westdown quarry.

As well as installing CCTV cameras and instigating the removal of fly tipped material, we have also sited more boulders at the entrance on Bulls Green Link Road – to prevent trespassing motocross racers using the layby to park their vehicles. Close cooperation with the local police also helped halt a planned rave from taking place and led to further police action.

Ian Strachan, strategic development manager, said: "We're grateful to local residents who alerted us to the unacceptable activities of a small minority. It's good to hear that our additional preventative measures have led to a drop off in the number of unsociable incidents."

Down in the woods

Our work to understand the impact of ash dieback disease and take appropriate action continues.

We are currently liaising with Natural England and the Forestry Commission on planned felling work for some affected trees and this is why a number of ash trees along Vallis Vale have been identified with orange and pink tree markings.

Alexandra Hemming, senior landscape architect, said: "Ash dieback is having a huge impact across the Mendips and, although it's heart-breaking, this felling is necessary to ensure the ongoing safety of those accessing the paths at Vallis Vale and Asham Wood."

Hanson is also updating the approved Forestry Commission Woodland Management Plan for the Asham Wood SSSI, developed as part of our proposals to reopen Westdown quarry. This revised approach, which includes a landscape survey, is being drawn up in conjunction with Natural England, Somerset Wildlife Trust and other stakeholders. We'll share more details with local stakeholders on this as the thinking becomes clearer.

We've also been tackling invasive giant hogweed along Vallis Vale. As well as being visually impactful, giant hogweed can be harmful, with chemicals in the sap potentially causing severe skin reactions, including blistering, pigmentation and long-lasting scars.

Hanson opens its quarries for international biodiversity competition QUARRY L/FE

Whatley quarry is among 12 of Hanson UK's sites participating in the fifth round of the company's biodiversity competition, the Quarry Life Award. Westdown guarry, Asham Wood and Vallis Vale are also open to potential projects.

The international competition is run every three years by our parent company HeidelbergCement to raise the

understanding of the biodiversity value of quarrying sites during and after extraction and share new best practices. At a national level, the competition has two streams; research and community, both of which offer a £5,000 top prize. The research stream focuses on scientific projects that increase knowledge of quarry-specific ecology and/or lead to improved biodiversity and is aimed



principally at academics. The community stream is for projects that educate about biodiversity in quarries or help the quarry raise awareness among the public about biodiversity at extraction sites. This stream is open to everyone - individuals, students, schools and community groups.

Justin Collis, Hanson area operations manager, said: "The aim is to encourage projects which can support or enhance the work we are already doing to improve biodiversity. We also want to hear from people who have ideas which will create a better understanding of the importance of guarrying and its vital role in improving the built environment."
